GRAND CAYMAN, 17 February 2022 - - Cayman National Corporation Ltd. ((CSX: CNC) KY) ("CNC"), announces that it has scheduled its Annual General Meeting for Wednesday, March 16, 2022. Shareholders have been notified.

At the Annual General Meeting, *inter alia*, shareholders will consider payment of a final cash dividend of 6 cents per share (CI\$0.06), to be distributed on March 23, 2022 (or as soon thereafter as possible) to CNC's shareholders of record as at March 18, 2022, for a total dividend for the year of 12 cents per share (CI\$0.12), as recommended by the Board of Directors.
