### **Voluntary Early Repayment and Cancellation of Loan Notes**

On 28 March 2018, the Cayman Islands Stock Exchange admitted to the Official List the £121,539,648 4.04% Fixed Rate Unsecured Loan Notes due 22 November 2032 of the Issuer (the "**Notes**").

The Issuer announces that on 15 June 2022 (the "**Relevant Date**") it made a voluntary early repayment of:

- the principal amount of £2,278,637 of the Notes; plus
- the interest accrued during a period beginning on (and including) 1 April 2022 and ending on (and including) 31 May 2022 on the principal amount of all Notes outstanding as at 31 May 2022.

Following such payment of the principal and interest, those applicable Notes were cancelled and were not available for reissue. Following such repayment, £60,128,977 of the principal amount of the Notes remained outstanding on the Relevant Date.
