Ladies and Gentlemen:

Reference is made to the Amended and Restated Investment Management Agreement, dated as of November 17, 2021 (as amended, modified or supplemented, the "<u>Investment</u> <u>Management Agreement</u>"), by and between AIG CLO 2019-2, LLC, as issuer (the "<u>Issuer</u>"), and AIG Credit Management, LLC, as investment manager ("<u>ACM</u>"). Capitalized terms used but not defined herein shall have the meanings specified in the Investment Management Agreement.

We are writing to inform you that AIG Global Asset Management Holdings Corp. has entered into a purchase and sale agreement, dated as of January 24, 2023, to sell ACM to an affiliate of Blackstone Inc. (such acquisition, the "<u>Transaction</u>"), subject to satisfaction of the terms and conditions set forth therein. Following the closing of the Transaction, ACM will continue to act as investment manager under the Investment Management Agreement.

We hereby direct the Trustee to distribute to or otherwise post this notice to the Holders and the Cayman Islands Stock Exchange.
