ON OR BEFORE DECEMBER 31, 2021 (BAR DATE)

TO ALL PERSONS AND ENTITIES WITH CLAIMS AGAINST THE FOLLOWING ENTITIES (COLLECTIVELY, THE “START GROUP”)

Start III Ltd. (“ START Ireland ”), an exempted company incorporated with limited liability under the laws of Bermuda, managed, controlled and resident in Ireland for Irish tax purposes

Start III USA LLC (“ START USA ”), a limited liability company formed under the laws of the State of Delaware
--

Start III Holding Ltd. (“ START Holding , and, together with START Ireland and START USA, “ START ”), an exempted company incorporated with limited liability under the laws of Bermuda, managed, controlled and resident in Ireland for Irish tax purposes

PLEASE TAKE NOTICE THAT, on July 23, 2021, START announced a plan of liquidation to wind-up its affairs in an orderly manner and subsequently to cease all business activities, and then to dissolve each remaining member of the START Group. Pursuant to such plan, START has established **December 31, 2021** (the “**Bar Date**”) as the deadline for each person or entity (including, without limitation, individuals, partnerships, corporations, joint ventures, trusts and governmental units) to file any proof of claim (a “**Proof of Claim**”) against members of the START Group. Any person or entity who fails to file a Proof of Claim prior to the Bar Date will be prohibited from filing a Proof of Claim against members of the START Group thereafter.

PLEASE TAKE FURTHER NOTICE THAT, all Proofs of Claim must be filed so as to be actually received on or before the Bar Date at the following address by first-class mail, hand delivery or overnight courier:

Proofs of Claim will be deemed timely filed only if **actually received** by START at the address above on or prior to the Bar Date. Proofs of Claim may **not** be delivered by facsimile, telecopy, or electronic mail transmission.

PLEASE TAKE FURTHER NOTICE THAT, all Proofs of Claim should include:

- (1) the name of the claimant;
- (2) the claimant’s address, telephone number and email address;
- (3) the total amount claimed; and
- (4) an itemized statement of support for the amounts claimed.

PLEASE TAKE FURTHER NOTICE THAT, all Proofs of Claim will be processed and settled following the Bar Date. After the completion of processing and settlement, proceedings will be initiated in which each member of the START Group will be wound up.

PLEASE TAKE FURTHER NOTICE THAT, you **MUST** submit a Proof of Claim in accordance with the procedures set forth herein to be eligible to receive a distribution on any claim you may have against any member of the START Group. For the purposes of this notice, the word “claim” means: (a) a right to payment, whether or not such right is reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal, equitable, secured, or unsecured; or (b) a right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured, or unsecured.
